The Veterans' Legal Aid Society, funded by private donors, is an awarded program available to veterans and their families with financial need who require the assistance of an attorney. You must adhere to the following application guidelines in order to qualify for full consideration.

ALL APPLICANTS

In order to demonstrate financial need, all applicants must provide the most recent filed tax returns, with all attached schedules, W-2s and 1099s. Additionally, all applicants must provide documentation of veteran's status through a copy of the DD-214.

AWARD

After verification of eligibility, the Board members will meet to ascertain the amount of assistance that it could provide to the applicant through pro bono attorney time or funding towards the legal assistance of our registry attorneys. The dollar amount of these awards is contingent upon the level of funding the organization receives and is at the discretion of the Board of Directors.
